

# VATSIM Romania vACC Constitution

## Objectives

VATSIM Romania is the reference and meeting place for Romanian Air Traffic Controllers and Pilots, on VATSIM Network under VATEUR and VATEUD Policy.

## Responsibility

VATSIM Romania is a non monetary organization with no financial income, is owned jointly by its active ATC and Pilot members, under the operational responsibility of the Director's, we are a part of the VATSIM network and is responsible for the whole Romania Airspace, described below, belongs to VATEUD Division of VATEUR Region.

All documents, images and programs produced specifically for VATSIM Romania, become ownership of the vACC unless specifically noted at the time the material is made available.

The person providing the material shall inform the staff of any possible problems regarding copyright at the time the material is provided to VATSIM Romania, or as soon as this is discovered.

## Romanian Airspace

Romanian Airspace are 1 FIR, divided in 9 ACC.

VATSIM Romania are 1 main airport (LROP), and other 9 airport's (LRAR/LRTR/LROD/LRCS/LRSM/LRBM/LRCL/LRCV/LRSB/LRTM/LRBS/LRSV/LRBC/LRCK/LRTC)

Romania Air Traffic Controller have also the authorization to control LUKK\_CTR above FL195 described on the LoA with Moldova vACC.

## Staff Member and Regulation

The Director of the vACC shall be elected from the active member of the vACC and may dismissed by the unanimous decision of VATEUD Staff as a VATSIM Policy.

In case of Director will declare officially absence on official vACC website, the Training Director will replace him with all duties, and the Deputy Director will be the new ATC Training Director.

The minimum requirement to become the Director and ATC Training Director is to hold C1 Rating at least, recommended for other INS Rating (I1), be a member of VATSIM Romania for at least 1 year and have 18 years old.

The Director and Deputy Director of VATSIM Romania are the only staff that has the authority to refuse a member the status of active ATC, Director or Deputy Director has the right to render a controller "inactive", and to not allow the member to provide ATC within the VACC's airspace until necessary procedures are completed for reactivation of his/her ATC status.

The Director and Deputy Director are the only staff that has the authority accepting or refuse the Visiting Controller, new staff member and any other action, with the recommendation from ATC Training Director.

### **Duties of Staff Member:**

- Ensure that all members follow the rules of this constitution, including the staff itself.
- Fulfil the assignments on a continuous basis.
- Plan and lead the works within his/her own assignments in VATSIM Romania.
- Respond to external communications and questions from members regarding his/her assignments within one week.
- Listen to the members of VATSIM Romania and take up suggestions and questions put forward from the members.
- Maintain an ordered record of external communications, agreements and documents, ready to be handed over to a successor.
